Visitation

Caleb Hitchcock Health Center

We have opened up to indoor visitations at the Caleb Hitchcock Health Center and Assisted Living and are following all DPH guidelines for safety. This week CMS released new indoor visitation guidelines for Skilled Nursing facilities. We are currently in the process of reviewing all of the changes and will communicate and implement the changes early next week. The new guidance represents a real step toward returning to everyday activities at the Caleb Hitchcock Health Center. Independent Living and Assisted Living

We are pleased to let you know that indoor visitation is going well and as vaccination rates increase, COVID-19 cases decline and travel guidance has been relaxing we have some updates to our visitation guidance.

As of Monday March 15, 2021 all visitors will be required to present proof of either:

- Vaccination completed more than two weeks before the visit, OR
- A negative COVID-19 PCR test collected within 7 days of the visit.

If you have this proof, you may call or email our Aquatic Receptionist with the date and time you intend to visit. Please note that:

- All Visitors must give 24 hour notice; and
- There are to be no more than 2 visitors allowed in an apartment at a time; and
- All visitors must be 18 years of age or older.

- Monday through Friday 10am-6pm

Testing

Monthly Point Prevalence COVID-19 testing for all Independent Living Residents was held on Wednesday, March the 10th. All test results received as of this writing are negative with 10 results still pending.

All Assisted Living residents and all Duncaster staff, Main Building and Caleb Hitchcock Health Center, have tested negative this week. The Caleb Hitchcock Health Center residents were not tested this week as Caleb is not currently in an outbreak.
